### Cocos Keeling Islands Fishing Trip

### Random Draw Terms & Conditions

#### Draw Prize

1. The GameX 2024 Random Draw Prize is a Guided Fishing Trip Package for a maximum of 4 people with Hello Backing Fly & Sports Fishing Charters at the Cocos Keeling Islands.
2. The Guided Fishing Trip Package comprises 7 nights twin share accommodation on West Island at the Cocos Keeling Island in January 2025, 6.5 days guided fishing with Hello Backing Fly & Sports Fishing Charters with two anglers per guide per day, all meals (continental breakfast & pre-prepared lunches/dinners), tender boat & fuel, and all soft drinks/water during activities, for a maximum of 4 persons in the amount of \$30,000.00 including GST granted by Exmouth Game Fishing Club Inc. (\$20,000.00), Hello Backing Fly & Sports Fishing Charters (\$6,000.00) and Cocos Keeling Islands Tourism Authority (\$4,000.00) which may only be applied towards:
  - a. 7 nights twin share accommodation on West Island at the Cocos Keeling Islands for a maximum of 4 persons from January 7-14, 2025; and
  - b. 6.5 days guided fishing with Hello Backing Fly & Sports Fishing Charters from in January 2025 including all meals, tender boat & fuel, and all soft drinks/water during activities, for a maximum of 4 persons.on terms to be determined and agreed by and at the sole discretion of Exmouth Game Fishing Club Inc, Hello Backing Fly & Sports Fishing Charters and Cocos Keeling Islands Tourism Authority.
3. The Guided Fishing Trip Package does not include:
  - a. flights and travel costs to the Cocos Keeling Islands; and
  - b. ferry fees; and
  - c. travel and medical insurance; and
  - d. flies and fly lines (tackle hire is available on weekly basis with a breakage fee of \$250. Rod hire is \$100 weekly with 4 available rods per week, flies can also be purchased); and
  - e. all alcoholic beverages; and
  - f. all Internet services (available for purchase on the island); and
  - g. gratuities.

### Claiming Prize

- b. Exmouth Game Fishing Club Inc. may at its sole discretion:

#### **Gamex 2024 Cancellation**

10. If for any reason any part of Gamex 2024 or the Gamex 2024 Presentation Night is cancelled by Exmouth Game Fishing Club Inc., then:
  - a. the Gamex 2024 Random Draw will not occur and no person will win the GAMEX 2024 Random Draw prize; and
  - b. the entrants of the Gamex 2024 Random Draw:

- i. fully and finally releases and discharges Exmouth Game Fishing Club Inc., Hello Backing Fly & Sports Fishing Charters and Cocos Keeling Islands Tourism Authority from any and all obligations and liabilities arising from or in any way related to or connected with the Gamex 2024 Random Draw or Gamex 2024 Random Draw prize; and
- ii. is barred from commencing or continuing any claim, suit, action or proceeding against any or all of Exmouth Game Fishing Club Inc., Hello Backing Fly & Sports Fishing Charters and Cocos Keeling Islands Tourism Authority in respect of any released or discharged matter.

### Governing Law

16. The:

- a. Gamex 2024 Random Draw;
- b. relationship between Exmouth Game Fishing Club Inc., Hello Backing Fly & Sports Fishing Charters and Cocos Keeling Islands Tourism Authority and the entrants and Winner of the Gamex 2024 Random Draw regarding the Gamex 2024 Random Draw and/or Gamex 2024 Random Draw prize; and
- c. these terms and conditions;

are governed by the laws of and applicable within the geographical territory of Western Australia.

17. Each entrant to the Gamex 2024 Random Draw agrees that the Courts of and in Western Australia shall have exclusive jurisdiction to determine any dispute or claim relating to or connected with Gamex 2024 Random Draw and/or Gamex 2024 Random Draw prize.

### Survival
